During the inspection the committee has observed lot of irregularities which are of very serious nature and the committee has recommended to withdraw the authority of testing of this testing centre.
- 3. Accordingly, this department has decided to withdraw and cancel the authorisation of testing centre which was granted vide letter no. 8-1/2004 dated 14.9.2010 w.e.f. the date of issue of this letter.
- 4. It is also further requested that you may also constitute a committee to enquire into the matter and a suitable action as per the university rules may be taken against the concerned officers/staff and rectify the observations as per the report of Director, CFMTTI, Budni. After the rectification of the shortcomings the same may be intimated to this department so that re-inspection can be conducted for award of the authorisation to the testing centre.
